# MEETING NOTICE:

The regular monthly meeting of the Troy Amateur Radio Association will be held on Tuesday, October 15th at 7:30 PM in Room 3051 of the Center for Industrial Innovation (CII Building), just off the west side of 15th Street, in Troy, New York. From Hoosick Street, turn south onto 15th. After passing under the pedestrian bridge, turn left into the RPI parking area. Walk across the pedestrian bridge, and go another 50 yards to the CII entrance on your right. After entering the building, turn left through the doors and go down the corridor along the row of windows. Room 3051 is at the far end on the right. Talk-in will be available on 147.27 MHz.

## SEPTEMBER MEETING IN BRIEF:

All officers were in attendance. All cash allocations previously approved for repeater repairs and maintenance were rescinded. Funds will be supplied to the Channel 13 Engineering Group on an "as needed" basis. It was also agreed that the Board be empowered to pay regular monthly expenses and up to 1/3 of the available cash assets on emergency expenses without prior approval of the membership. The President thanked KA2VBI and others for their work in the September VHF/UHF Contest and WA3RKB for the work on the first TARA Newsletter.

New repeaters in the IBARC link system (Doug Sharp, WB2KMY, and company) were added to the schedule on September 30th. These include the 224.14, 444.0, and 921.2 MHz repeaters in the Helderbergs, west of Albany, 447.225 MHz on Mt. Equinox in Vermont, and 921.1 MHz on Mt. Greylock in Massachusetts. The 442.1 MHz repeater in Utica and a "repeater to be named later" in the Kinsgton area will be added shortly. Bulletins on these repeaters are run simultaneously with the RPI W2SZ 146.82 and 224.42 linked repeaters and required no schedule changes. Rensselaer County ARES/RACES Association will soon be adding a new 147.345 MHz repeater to their link system, bringing the total number of repeaters served by the CDARC Bulletins to 18.

# AROUND THE CAPITAL DISTRICT:

September saw the Schenectady Amateur Radio Association jump back into action after the summer hiatus. SARA's participation in Field Day and the Flight '91 Schenectady County Air Show, the Empire State Games, and other public service events were discussed.

The Albany Amateur Radio Association had moved its meetings to the Colonie Community Center just before the Summer break and saw another jump in attendance for September's guest speaker, ARRL Hudson Division Director Steve Mendelsohn, WAZDHF. The October program will be presented by NZIUL, Sy Syvertsen on amateur satellite communications.

The day after the AARA meeting, many of us journeyed up to Ballston Spa for the Saratoga County RACES Association Hamfest. The club reports in excess of 700 paid admissions and is fast becoming the "Class Act" hamfest of the northeast. Dave Atwell, N2FEP, again deserves credit for a terrific package that included a VEC examination session and a seminar on ARRL activities by WA2DHF.

Saratoga County RACES Association has started a new Novice/Technician Class course at Saratoga Springs Junior High School. Attendees to their monthly meeting heard a program on the World Administrative Radio Conference (WARC '92) coming up this Winter in Barcelona, Spain. WARC '79 brought us new amateur radio frequency spectrum at 30, 17, and 12 meters but the conference will, in all likelihood, substantially wipe out many amateur microwave allocations in favor of CT2 (Second Generation Cordless Telephone), DAB (Digital Audio Broadcasting), HDTV (High Definition Television), and other emerging technologies. Link frequencies to orbiting amateur satellites may also be on the chopping block. Deep pocketed commercial interests have lusted after many of our frequencies for years and are looking forward to gobbling up even more of our precious spectrum.

NoBARC's September meeting featured Howard Lester, W2ODC, as guest speaker. His presentation "Cellular Phones...FM to Digital" provided a history of advances in this technology which only recently became a "boom". The club began its annual election procedure at this meeting with nominations for 1992 officers opened to the floor. Nominations will be reopened at the October meeting and the election held the following month by mailed paper ballot.

Various Rip Van Winkle ARS members had to skip the August meeting to provide a demonstration of amateur radio capabilities to the Valatie Rescue Squad. Elections in September yielded new suckers, er, uh, officers for 1991-92; AA2Y President, WE2G Vice President, KB2CCB Treasurer, and N2LDR Secretary. Our congratulations (sympathy) on your election. The club is also currently running an eight week Novice/Technician Class course at Icabod

Crane Middle School. Columbia County moved their ARES and RACES nets to different evenings and the Greene County ARES Net has moved to Sunday evenings.

Rensselaer Co. ARES/RACES Association returned from summer break with several positions open. Bill Eddy, NY2U, resigned as Newsletter Editor citing his election to the Presidency of the new Troy ARA. EC Carli Drake, WB1BTJ, will be appointing an AEC for each zone. RO Joe Hoffman, KA2AXN, reported on the repeater system and that guru Lance Liscari, WS2B, was devoting more time to his studies at the "Tute". Neil Anderson, N2LOD, and others will be completing final assembly of the repeater link system. Stephan Anderman, WA3RKB, will take over as Net Manager of RCRN and seek a rotation of regular NCS ops. RKB also agreed to take over as Program Director and has since announced that club will welcome ENY SM Paul Vydareny, WB2VUK, ENY SEC Bob Schaps, WB2NVR, and ARRL Hudson Division Director Steve Mendelsohn. WA2DHF as guest speakers in the months to come.

SOVARC, the Southern Vermont Amateur Radio Club, organized just last year, is growing at a rapid pace with a paid membership of 34. At their September meeting, a nominating committee was selected to procure candidates for their first formal election slated for later this Fall. New officers will be seated in January. Micky Corrow, N1JIF, will take over as Newsletter Editor. The group now has enough certified VEs to establish their own examination sessions and an activities committee was also selected. Many members of the club provided communications during the move of patients from the old Mary Hitchcock Hospital to the new Dartmouth-Hanover Medical Center on October 5th.

Finally, Overlook Mountain ARC (Thanks for the newsletter, guys! - Ed.) recently ran a Skywarn Training Class at Central Hudson Power. Their Skywarn net meets at 7:00 PM on the first Monday of each month on the 147.255 repeater. Their RACES net meets on the other Mondays, also at 7:00 PM (except the 3rd Monday when they run their "Meeting on the Air"). They're still looking for an Editor for their Harmonics newsletter; seems like Tom Lindtveit N2GQS has had the "interim" title forever.

## **EMERGENCY AUTOPATCH SERVICE:**

Many of the repeaters here in the Capital District have instant, emergency access to local police and sheriffs' departments.

On the 147.00 and 147.24 MHz repeaters, 911\* will connect you to the Saratoga County Sheriff's dispatcher. On 147.18 MHz (and the entire Rensselaer County link system on 146.76, 147.345, and 442.2 MHz when completed), 911 will connect you to a dispatcher at Rensselaer County Sheriff's Office. Dialing 31\* on the 147.12 repeater in Albany, will connect you to a dispatcher in the Albany County EOC. All four repeaters' emergency call systems can dispatch help no matter where you are (the dispatchers can all interconnect over their own communications system across county lines).

# HAM RADIO SHOW ON LOCAL CABLE TV:

The Talk Show, produced by Seadrift Productions, devoted an entire hour to amateur radio on their latest program, which was taped September 18th at CableVision's studio in Rensselaer. Hosted by Bob Hebler and directed by George Bowen, N2LQS, the program featured the ARRL's latest video, New World of Amateur Radio. Stephan Anderman, WA3RKB, "The Voice of CDARC" appeared on the show as a guest. This program, at presstime, has already been aired by several cable systems throughout the Capital District.
