
Schenectady Museum Amateur Radio Association

## Azden Product Review de N2NEH, Chris Linck

The following saga tells of the adventures of N2NEH with the Azden Corporation of America.

I took delivery of one of those new Azden 6 meter mobile FM radios on May 20, 1993. The price was \$389 00, plus tax and Azden ships the radio **FREE** of charge.

I immediately attacked the owner's manual and learned the basic "how to" for power-up and antenna requirements. The radio proved to have a very good receiver but I was a mite puzzled by the Azden manual's Japanese translations to literal English. It took me about three hours of study plus some trial and error before I was fully able to program and operate the radio. After that, it's now a piece of cake!

My first 6 meter contact was with WA1MIU on 52.525MHz; next we moved to the Mt Greylock 23 repeater. These initial contacts were conducted with 10 watts (output power) fed into a 1/4 wave mag mount antenna located in my attic. Later I went "hill-topping" with a home-brew 1/4 wave ground plane.

While having a good time up on the hill, disaster struck. At first the relays in the send and receive circuit did not un-key immediately after releasing the push-to-talk button on the mike Quickly I made some checks to make sure it wasn't caused by operator error or stray Rf floating around. The problem progressed to the point that the relays finally wouldn't un-key at all.

I contacted Lou at Azden on Monday, May 24, 1993. Explaining my problem to him was an easy exercise of one ham talking to another. "Send it back," he said. "We'll push it through and make it right."

Although the Memorial Day long weekend was delaying shipping, Lou called me on June 1, to confer on the problem. One hour later he called me back to tell me that the problem was fixed and Azden was immediately shipping the radio back to me. It showed up on my back step on Thursday, June 3, 1993.

The radio was immediately put back into service and the problem was truly gone. The folks at Azden even had reprogrammed the radio with the specs I had.

## Jim Rafferty, N6RJ, Dies at 43; Was V.P. of Ham Radio Outlet

Jim Rafferty, N6RJ, the vice president of Ham Radio Outlet, died June 13, 1993, in Yorba, Calif., after a long battle with cancer. He was 43 years old, born June 19, 1949, in Rockford, Ill., and was the husband of Shirley Rafferty.

An active operator, Rafferty, is remembered for his participation in the first operation from Kingman Reef, KP6KR, in 1974. He was one of the team to gather around the microphone and put out the first CQ from the new country.

In recent years he operated from the Cayman Islands as ZF2FL and later as ZF2JR, specializing in 40 meters. He held the world record for single-band 40 meters in the CQ Worldwide Phone Contest.

One of his labors of love was, every fall, to update the DXCC countries file for the "CT" software used by many active contest operators. He mailed copies of the new file to friends around the country who passed it along to others.

Rafferty also teamed with KL7GRF to translate the famous "*W9IOP Second Op*" into software and then marketed it as the N6RJ Second OP.

Although an executive at HRO, Rafferty manned the "800" line in Anaheim, side-by-side with other store employees, over the years answering question for thousands of ham callers. He was friendly and knowledgeable, always knowing where the best deal was, even if it wasn't at HRO.

A final honor for N6RJ was appearing on the cover of the July, 1993, issue of CQ*Magazine*. He saw a copy of the magazine, just off the press, only hours before his death. The new French ARSENE Amateur Radio satellite became available for Mode-S use on June 1, 1993 The 16-kHz uplink passband is centered at 435 100 MHz, with a corresponding downlink passband centered at 2446 540 MHz. Authorized modes include SSB and CW

The investigation continues concerning the failure of the satellite's 2-meter packet downlink.

The founder of Yeasu has died. Sako Hasegawa, JA1MP, died June 12, 1993, in Tokyo, Japan. He was 64 years old.

Hasegawa had been involved in the introduction of SSB to Japanese amateurs in the 1950s. In the 1960s he was a driving force in opening up other modes, particularly radioteletype.

## F.C.C. Takes Action... The <u>ARRL</u> Letter

The F.C.C. has fined a Florida woman for unlicensed operation on 2 meters. Margaret G. Taylor of Vero Beach, received a Notice of Apparent Liability for \$2,000 for allegedly operating on 145.53 MHz. on February 8, 1993.

In another action, the F.C.C. has fined Rodney S. Sedeno, NH6UC, a Technician Class amateur. \$2,000 for unlicensed operation on 27.085 MHz, on May 12, 1993. Two others also were fined \$2,000 for "*Out-of-band*" CB operation.

\* \* \* \* \* \*

The National Conference of Volunteer Examiner Coordinators met June 17, 1993. The following excerpt was given by John Johnston, Chief of the FCC's Personal Radio Branch Special Services Division, and several of the FCC's data processing specialists.

The FCC estimates with the new computer upgrades and electronic automation with the VECs the paper applications could take just 10 days for processing (rather than six weeks or more). Those that are electronic disk files could take three or four days, and electronic applications via an FCC BBS might take as little as <u>two days</u>!

## New HF Beacon Station...

A new beacon began operation May 13, 1993, from Cape Prince of Wales, Alaska (67N, 168W). Its call sign is NAF and it runs 100 watts to a 3-band fan dipole on the following schedule. 00 and 01 minutes after the hour on 5.604 kHz; 20 and 21 minutes after the hour on 11.004 kHz; and 40 and 41 minutes after the hour on 16.804 kHz. Transmissions are narrowband CW and FSK

The beacon will be monitored by government facilities in Fairbanks, Alaska; Seattle,

Washington: State College of Pennsylvania; and San Diego, California. The project's sponsor is the Navel Security Group Command in Washington, D.C.

A government spokesman said the project is "*purely scientific*" The purpose of the project is to prove a "*rigorous verification*" of field strength models done by HF propagation prediction programs like IONCAP which are used, for example, to generate the predictions published each month in *QST*. Reception reports are encouraged and will be acknowledged with a colorful QSL card. Another beacon from Rarotonga in the South Cook Islands, is scheduled to go on the air in the fall on low VHF frequencies as well as the three NAF frequencies. TN

# Can you receive payment for your Amateur Radio assistance?

No, the FCC regulations prohibit payments for the use of an Amateur Radio station. Specifically, 97.112 No renumeration for use of station.
(a) An amateur station shall not be used to transmit or receive messages for hire, nor for communication for material compensation, direct or indirect, paid or promised.

Note that this rule does not prohibit you from being reimbursed for incidental expenses unrelated to your radio communication. If you assist at a disaster scene 100 miles from your home, you are not prohibited from receiving reimbursement for out of pocket travel expenses unrelated to your radio communication. For example, if as an American Red Cross Disaster Services Volunteer you are flown to the scene of a disaster where you happen to use Amateur Radio as part of the relief effort, you are not required to pay your own air fare.

In summary, the FCC encourages activities that benefit the public. In the FCC letter regarding the NYC Marathon, FCC Private Radio Bureau Chief Robert Foosaner wrote, "Please inform your group that their licenses are not endangered by participating in the marathon. They have my support and my personal thanks for serving the public."

Public service activities are an important, if not the primary method, of training for participation in actual disasters and emergencies. When the public needs your help, often in a life or death emergency, they need trained assistance. You would not want untrained paramedics at an injury accident - nor do you want inexperienced hams handling communications at a quake damaged hospital.

#### Press use of Amateur Radio

Both business use and broadcasting, which the FCC defines as "the dissemination of radio communications intended to be received by the

public directly ... ", are prohibited within the Amateur Radio Service.

In general, the media may not directly use Amateur Radio to collect information for their broadcasts However, there are two important exceptions First, anyone may listen to ham radioconversations. In the FCC's Report and Order 79-47, they wrote that it is okay for broadcasters to retransmit Amateur Radio transmissions. The broadcaster does not need permission of the FCC nor of the stations involved. This means that broadcasters were legal in retransmitting live descriptions of earthquake destruction emanating from Mexico City.

The days are long past when a hand held radio, or even a phone patch, could impress your local police and fire officials into incorporating ham radio in their disaster planning. Today, these planning officials have their own phone patches, their own cellular radiotelephones, and are building packet systems on their public safety frequencies. To meet today's challenges we must work together as a skilled team to provide creative communications solutions, inventing new technologies and finding innovative uses for traditional systems, like HF SSB, VHF FM, and ATV.

#### "But is this legal?"

If you are in doubt as to the legality of a particular Amateur Radio operation, the ARRL recommends contacting your local Section Manager or other ARRL official. He or she can provide an answer or pass the question to the appropriate Amateur Radio advisor. Contacting the FCC for an opinion is generally not recommended.

The FCC prefers for the Amateur Radio Service to be self-policing. Writing to the FCC asking for a legal opinion is generally the wrong way to approach your question and has, at times, resulted in opinions developed without a full presentation of the facts.

In one instance, a hypothetical question involving phone patches was posed to two separate FCC offices: Not surprisingly, the ham received two contradictory opinions. Depending upon whom you asked, you could have created a new policy to which not even the FCC would agree to! References ------
