


### Info about the Freihofer Run for Women

# FCC SEEKS ASSISTANCE IN CURBING UNLICENSED 10-METER INCURSIONS

The FCC has requested the assistance of ARRL Amateur

Auxiliary/Official Observers in monitoring for illegal operations on the 10 meter band http://www.arrl.org/FandES/field/org/oo.html. The request came in an April 28 letter from FCC Special Counsel Riley Hollingsworth, who says incursions on the band by

apparently unlicensed operators continue to be a major enforcement headache.

"This is the first phase of a renewed investigation effort and may be thought of as detect, collect data, and report," said ARRL Field and Regulatory Correspondent Chuck Skolaut, K0BOG. Skolaut forwarded the request to members of the Amateur Auxiliary May 1.

Hollingsworth said the FCC wants help with a stepped-up effort over the next six months-from May through October to identify any unlicensed operation on 10 meters, whether from business entities--including trucking companies-truckers or other individuals operating domestically." Hollingsworth said the FCC does not need directionfinding but would appreciate where possible "the names and cities of the operators, and license plate numbers and state if from a vehicle "

Skolaut said the FCC would like to concentrate on obtaining reports of this type of operation to help identify specific areas of the US where this problem is prevalent, although he concedes that not all illegal 10-meter operation originates in the US. "The FCC asks that OO's obtain as much information as possible and send their reports through normal channels to ARRL Headquarters," he said. The decision to record the transmissions of suspected interlopers was left to the discretion of the individual OOs.

The FCC request was made under a longstanding agreement between ARRL and the FCC regarding the use of Amateur Radio volunteers to assist in enforcement.



### **New 60m USB Band**

The new five-channel 60-meter domestic secondary amateur allocation becomes available to US Amateur Radio operators at midnight local time on July 3.

The FCC Report and Order granting the allocation was published June 3 in the Federal Register. Federal government users are primary in the 5 MHz band.

The FCC has granted amateurs use of five 2.8 kHzwide channels with center frequencies of 5332, 5348, 5368, 5373 and 5405 kHz. The channels will be available to General and higher class licensees. The only permitted mode will be upper-sideband USB phone, and 50 W ERP is the maximum power allowed.

The FCC has approved the new 60m band, although it's not really a band in the strictest sense being just five fixed frequencies. The only mode permitted is upper sideband, so the first column below contains the "window" frequencies and the second is the suggested the carrier frequencies:

Users of the 60-meter channels should set their carrier frequency 1.5 kHz lower than the channel center frequency. ARRL suggests restricting transmitted audio bandwidth to 200 Hz on the low end and 2800 Hz on the high end for a total bandwidth of 2.6 kHz.

ARRL recommends that amateurs considering modifying existing amateur equipment for operation on 60 meters contact the equipment's manufacturer for advice

The chosen frequencies are a result of a small group of amateurs operating under an FCC-granted Experimental Class license for the past two years.



### Incumbents elected in Eight ARRL sections

Eight incumbent ARRL section managers have earned two years terms, three of them in contested races. Ballots were counted May 20 at ARRL Headquarters.

In the Maryland/District of Columbia Section, Tom Abernethy, W3TOM, turned away challenger Vic Curtis, WA3YUV, 826 to 266.

In the San Joaquin Valley Section, Charles McConnell, W6DPD topped Thomas M. "Mike" Zane, N6ZW, 304 to 251.

In the New Hampshire Section, Al Shuman, N1FIK, defeated Russell J. Santos, K1TSV, 478 to 95.

Sitting ARRL section managers in five other sections were unopposed for election or re-election and were declared elected. They are Dick Flanagan, W6OLD, Nevada; Bill Hudzik, W2UDT, Northern New Jersey; Bob Beaudet, W1YRC, Rhode Island; Mel Parkes, AC7CP, Utah, and John Dyer, AE5B, West Texas.

All new terms of office begin July 1.

### SPECTRUM PROTECTION ACT HR 713 - GETS A BOOST

The chairman of the Senate Communications Subcommittee, Montana Republican Conrad Burns, has signed on as a cosponsor of S 537, the Amateur Radio Spectrum Protection Act. The commitment by Burns, the expected architect of the Senate's spectrum management legislation, indicates that the measure--an ARRL initiative on its third attempt inCongress-now has his attention. Burns' cosponsorship also could convince others to follow suit. (It may also indicate the bill may become a rider to Burns' other legislation.) "Actually, this is the best opportunity that we've ever had to get this bill through, because more members of Congress than ever before are paying attention to ham radio now," said Haynie, who's been in Washington this week to speak about Amateur Radio issues with lawmakers and regulators. In addition, Haynie pointed out, the House and Senate will be considering major spectrum reform bills, and the Amateur Radio Spectrum Protection Act could serve as an amendment to that sort of legislation.

HR 713 and S 537 are aimed at ensuring the availability of spectrum to Amateur Radio operators. The legislation would protect existing Amateur Radio spectrum against reallocat ions to or sharing with other services unless the FCC provides "equivalent replacement spectrum" elsewhere. Bilirakis and Crapo, both Republicans, have twice before sponsored similar legislation at the League's recommendation.

"The League is doing all it can, but we know the success or failure will be in the hands of the amateur community," said Haynie, who pledged the ARRL's continuing efforts in Washington to get the bill enacted. "Letters and e-mails are the key to getting legislation passed."

A sample letter is available on the ARRL Web site. Those writing their lawmakers are asked to copy their correspondence to the League via e-mail at <a href="mailto:specbill03@arrl.org">specbill03@arrl.org</a>.

The measures would amend the Communications Act to require the FCC to provide "equivalent replacement spectrum" to Amateur Radio and the Amateur-Satellite Service in the event of a reallocation of primary amateur allocations, any reduction in secondary amateur allocations, or "additional allocations within such bands that would substantially reduce the utility thereof" to amateurs.

# Broadband Over Power Line Poses HF Interference Threat

For those of us not quite in the loop... what is BPL/PLC and why does it matter?

I'm not really going to go into the details of it. I will provide some links that go into great detail about what BPL/PLC is, and what the effects are/will be. Suffice it to say that Broadband over Power Lines (BPL) also known as Power Line Communication (PLC) is a new relatively new technology that has been used somewhat in Europe and in Japan. It has had a very negative impact on HF communications in these places where it has been implemented. Basically what is does is use power lines to distribute data to computers, and these power lines that you see everywhere work just like antennas, very large dipoles in essence, and the frequency that this new technology occupies is the entire HF spectrum and beyond. And now there is a proposal to implement this technology here, in the U.S. What's worse is the FCC is looking really hard at accepting it and allowing BPL/PLC to be implemented. We need numbers commenting against FCC Docket 03-104 -- and now. 500+ isn't going to cut it. Now if we could get even 5,000 that would be a "decent" showing, although honestly all licensed Hams and SWLs should be made aware of this and shown how to file their comments opposing this new technology ASAP.

If we don't and in a few years the HF bands are nothing but electronic hash we have no one else to blame but our own lack of knowledge or sheer laziness. Make no mistake about it, this is a very real threat to the entire HF spectrum, Ham bands and all.

Just imagine S-9 electronic "hash" from approximately 2 MHz to around 60 MHz or so, continuously.

Now imagine how much fun that turning on your HF rig would be and how effectively that you could communicate under this type of circumstance... Getting an idea of why it matters?

Have fun. Do membership drives, work parades, make yourself seen. Find new ways that you can help your EMA, Red Cross, Salvation Army and local hospitals. Get involved with SKYWARN and weather spotters. If your community has storm sirens get involved with the tests and hold a net during the test. Compile the reports and send them to the responsible party for the sirens. They can't monitor them all and would appreciate knowing which ones are and are not working. We hold a siren net the first Wednesday of the month. Not everyone can participate but those that can do. It also allows some of those that can't participate otherwise to participate. Lady that answered the phone recognized who he was right away. Got him the help he needed and then called him at home in a few days to make sure he was doing ok. She was one of the dispatchers that we fed on one of our cookouts.

Don't overlook your new hams. They want something to do with all the new toys. Some of them don't know about ARES. It's our job to educate and elmer them. (BTW, I've only been a ham for 2 1/2 years. I was appointed as EC after being a ham for 1 year.)

In addition to his amateur radio activities in Columbia County, Dave was an excellent volunteer examiner in that he assisted in giving amateur radio exams to local prospective amateur radio operators, as well as instructing local amateur radio operators.

My wife and I, fondly remember taking the Entry Level Technician Course at Hudson Valley Community College in 1989. Dave was a wonderful instructor and Elmer in that, he took a personal interest in the people in the class. I had a difficult time with the five word per minute code instruction. I kept freezing and Dave would come over to me and gently calm me down. Dave used to tell a story about me being so nervous with CW that he would keep a handful of pencils ready for me, because I kept breaking the ends off the pencils when copying CW.



A Good Friend that will remain in our memories On the final evening of the course, I passed the test with 75 words straight copy. You could see the look of pride and accomplishment in Dave's face, when I finally turned in my test and he smiled as he reviewed it.

After checking my copy, he came out into the other room to congratulate me. He said, great job kid you got your ticket. If it were not for Dave Watrous, I might not have been an amateur radio operator, today. His mentoring and friendship is one of the main reasons that I now teach the basic course for the last ten years and try to be very active in ARES and RACES.

He said to me, "Getting your ticket is a two way street, you benefit from the hobby but teaching others and performing public service is the way you pay it back. Dave also encouraged a group of local female amateur radio operators to form the re-birth of a local SAYLARC group.

Yes, Dave lent a warm helping hand to everyone he met. He was, indeed, a true mentor, in every sense of the word. He, Dave, brought dignity to the hobby of amateur radio.

Our thoughts and prayers are extended to the Watrous family. God bless you, Dave. Although you've left us, physically, your spirit will live on, and you'll not be forgotten.

### To ALL New York State ARRL Members

The final session of the New York State Assembly for the year 2003 will be Thursday, June 19. We have only a few days left to get our antenna bills passed. Once again we need your help.

The legislature has had a lot of distractions in 2003 - a war in Iraq and then overriding the Governor on the budget. Our bill has not frankly not been a priority. Your letters, phone calls, and faxes could change that.

We need to pull out all the stops and press for passage of our bill, NOW. There is little time left in this session.

In the Senate the bill, S63, needs to be "put on the active list" on the Senate calendar and brought out for a vote. Remember the senate passed this same bill last year. Please ask the following three senators to put our bill on the active list
