You and the Law!!!

For those of you in the amateur community and others who read this series of articles, the purpose of this column is to keep you informed and up-to-date as to your liability under the laws of the State of New York. This month we bring you information supplied to us from the ARRL in relation to the new NY State cellular phone bill which has just recently become law in this legislative session.

New York cell phone law does not apply to Amateur Radio: The widely reported New York bill banning the use of hand-held cell phone while driving should have no affect on Amateur Radio mobile operation, according to ARRL General Counsel Chris Imlay, W3KD. "There is no ambiguity in the bill," he said. The bill, A.9280, was signed into law recently by Gov George Pataki, a former amateur. It requires cell phone users to use hands-free devices when calling. The measure specifies "mobile telephone" use, and defines a "mobile telephone" as a device used by subscribers to a wireless telephone sevice. That, in turn, is defined to specify a commercial two-way wireless telecommunications service that accesses the public switched telephone network. The bill also specifies "using" as holding the mobile telephone "to, or in the immediate proximity of, the user's ear." The new law will be phased in starting November 1. It calls for fines of up to \$100. The measure also calls upon the New York Commissioner of Motor V chicles to study the effects of the use of mobile telephones "and similar equipment" in conjunction with the operation of a motor vehicle and report back to the legislature in four years. SILENT KEY - "Mister Guitar" Chet Afkins - W4CGP

Guitar picker, music legend and Amateur Radio operator Chester B. "Chet' Atkins, W4CGP, of Nashville, Tennessee, died June 30. He was 77. Known as "Mister Guitar," Atkins hailed from East Tennessee and began his musical career playing fiddle, but later earned his reputation as a guitarist. He went on to become the most-recorded solo instrumental musician in history.

Form only WA4CZD, Atkins, a General licensee, obtained the vanity call sign W4CGP in 1998—the suffix standing for "certified guitar picker." He was an ARRL member. He won 14 Grammy awards during his career and was elevated to the Country Music Hall of Fame in 1973.

He was presented with a Lifetime Achievement Award in 1993 by the National Academy of Recording Arts and Sciences in part to recognize his guitar-picking technique as well as his wide influence on music. He had more than 100 albums to his credit.

In addition to his own success as a performer, Atkins helped launch the careers of other notable performers. He is given primary credit for developing the uptown Nashville Sound that helped country music to compete with pop music.

In his later years of performing, he sometimes paired up with musicians from the pop and jazz worlds and was a frequent guest on the radio program "A Prairie Home Companion."

A funeral service for Chet Atkins was held July 3 in Nashville's Ryman Auditorium, which formerly served as the home of The Grand Ole Opry where Atkins performed for many years.

<u>UPDATE: N.Y. State Antenna Bill Still Needs Your HELP</u>

We hope you had a great Field Day and that you will have a safe 4th of July with family and friends. We hope you can find time in the next week to act on the meter below.

Because many of you recently took the time to make telephone calls and send e-mails Assembly bill A.1565 was reported out of the Ways and Means Committee on June 27 just before the Assembly took a break for the July 4th holiday. Thanks for that effort on behalf of your fellow New York State hams. As you are aware, at least some of us need to have towers so Amateur Radio can continue to provide emergency communications in national and international disasters.

The Assembly plans to return along with the Senate for business on July 16th. Initially we had been told that the legislature would do no business except budget items once they recessed at the end of June, but now Albany insiders tell us that is not the case and that our bill still has a chance of passage in 2001. It's not over yet! Some of you may now have the opportunity to speak personally with your legislators at local events held during the Independence Day holiday. Please do so if you get the opportunity.

At this point we can get the bill enacted if everyone contacts the three key people listed below via letter, telephone and e-mail. These legislative leaders need to hear from you AGAIN and NOW! Even if you have contacted them before, please do so again. We must act quickly and again flood them with calls. Please encourage others to do the same.

Like you, I wish we did not have to do it this way, but unfortunately this is the way system operates in New York State.

Please immediately telephone, and e-mail the following legislators asking them to bring our bills to the floor for a vote when the session resumes after July 16th:





Our message to them: "Please bring A.1565 and S. 2893 to the floor for a vote so New York State Amateur Radio operators can continue to serve their communities, at no cost to the state, in times of communication emergencies like those which recently took place during the Texas and Louisiana floods. These bills do not limit local government. The federal government did that sixteen years ago when they issued a limited federal preemption of local government in amateur antenna installations which has become knowns PRB-1."

For those who can do more there will shortly be two lists on the Hudson Division Website, http://www.arrihudson.org, which have the telephone numbers and e-mail addresses of the members of the Senate Rules Committee and another with those on the Assembly Rules Committee. Please call the Senate Rules Committee list first. It is shorter and at this point more important that they hear from us.

Current Status of the bills:

Thanks to those concerned New York State Amateur Radio operators who recently sent e-mails and made telephone calls to Albany our bills are not dead. You did write and call didn't you? If you have not already contacted your local legislative representatives - New York State assemblyman and senator - please do so with a telephone call and e-mail.

Both Assembly bill A.1565 and Senate bill S.2893B are currently in the Rules Committee and can immediately be brought to the floor for a vote thanks to the efforts of many dedicated New York State hams concerned that others may have effective antenna systems.

Our Assembly bill A.1565 recently gained a co sponsor, Paul D. Tonko of Amsterdam, NY and multi-sponsors Robin Schimming er and Richard A. Smith both of Erie County, and Harvey Weisenberg of Long Beach on Long Island.

Recently we have been told that some legislators are reluctant to act on the bills or perhaps vote for them because they feel the bill limits local government. Whenever we have heard this we remind them that this is not the case. Local government has been limited on the issue of Amateur radio antennas for the past sixteen years ever since the FCC issued FRB-1 in 1986. Our bill simply reminds New York State local government of that limitation and is aimed at saving both Amateurs and local government time and mone y implementing the provisions of the limited preemption we know as FRB-1.

Thank you for your efforts in accomplishing this important task. We would not ask you to do it again unless it was very important. It is!

Field Day 2001 Reaches A New High !!!!

Astronaut Susan Helms, KC7NHZ, took time out aboard the International Space Station to join in the ARRL Field Day fray last weekend. The operation was believed to mark the first time anyone participated in Field Day from space.

Helm's worked several dozen stations-most of them Field Day operations-as the ISS passed over the US. ARRL Contest Branch Manager Dan Henderson, N1ND, says the NA1SS contacts will count for Field Day credit, but they will not count for satellite bonus points.

Helm's sounded like a veteran contester during Field Day, although not without some confusion as to what exchange she should transmit. Initially acting on incorrect information, Helm's was giving out "one alpha maritime mobile-Russia" for a Field Day report. Later, she resorted to "1 alpha battery on the space station."

The NAISS Field Day operation infused a lot of enthusiasm into the occasion.

"This Field Day is the one I'll remember the most, even after doing FD for 40 years," said ARRL Wisconsin Public Information Coordinator Jim Romelfanger, K9ZZ. Romelfanger worked NA1SS as part of the WB9FDZ Yellow Thunder Amateur Radio Club Field Day crew. "Susan was having a ball up there!" he said.

Dave Swartz, KC7RRH, said his club's Field Day operation was another lucky enough to snag a contact with NA1SS. It happened almost by accident. Swartz, who operated with the Federal Way Amateur Radio Club's WA7FW setup in Washington, said the group was set up for a packet contact via the ISS when he heard Helm's voice coming over the speaker. Although he was on 20 meters at the time, he grabbed the mike at the packet setup next to him and made the QSO. Swartz said he was "very psyched" about working Helm's but disappointed not to get the bonus points.

Henderson said that ISS contacts will not count for bonus points because the ISS is not an "Amateur Radio satellite," as rule 7.3.7 specifies http://www.arrl.org/contests/announcements/rules-fd.html. Henderson said that, because of their nature, bonus points "need to be readily available to everybody," and the ISS offers only a limited window of opportunity.

As for the correct Field Day operating class for NA1SS, Henderson said there is more than one possible choice, but the question is largely academic.

"Whatever exchange she sent out, count it as a valid contact for Field Day and enjoy the experience," he said Field Day entries require a list of call signs worked by band and mode.

Henderson said Helms' ISS Field Day entry will end up "in a class by itself."

Canadian stations QSL to Radio Amateurs of Canada, 720 Belfast Rd-Suite 217, Ottawa, ON K1G 0Z5. A self-addressed, stamped envelope is required to get a QSL in return.
